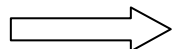

FOUR YEAR OLD Preschool Program for students age 4 by September 1, 2012

- PROGRAM 1** 5 Full Days from 7:45am-2:15pm - Wednesdays at 1:45 p.m.
Option: Before and/or Aftercare may be added to this program from 7:00-7:30am at \$2.30 per morning and from 2:15-6:00pm (1:45-6:00pm on Wednesdays) at a rate of \$4.50 per hour as needed. There are no minimum hours or days required. Students must be Pre-registered to use this program. Please see the Childcare contract for more information.
- PROGRAM 2** Monday, Wednesday & Friday from 7:45-11:00am
Option: Before care may be added to this program from 7:00-7:30am at a rate of \$2.30 per morning. There are no minimum days required per week. Students must be Pre-registered to use this program. Please see the Childcare contract for more information.
- PROGRAM 3** 5 Mornings from 7:45-11:00am (5 Afternoons may be available)
Option: Before care may be added to this program from 7:00-7:30am at a rate of \$2.30 per morning. There are no minimum days required per week. Students must be Pre-registered to use this program. Please see the Childcare contract for more information.
- PROGRAM 4** Monday, Wednesday & Friday Afternoons from 11:00am-2:15pm (Wednesday-1:45pm)
Option: Aftercare may be added to this program from 2:15-6:00pm (1:45-6:00pm on Wednesdays) at a rate of \$4.50 per hour as needed. There are no minimum hours or days required. Students must be Pre-registered to use this program. Please see the Childcare contract for more information.
Non School Day Option: When school is not in session, care for St. Peter students is available (except for holidays stated on contract) from 7:00 am-6:00pm. Students must be Pre-registered to use this program. Please see the Childcare contract for fees and days available.

All programs are subject to change and may not be available due to insufficient enrollment. You will be notified and given the opportunity to change to another program. If you do not wish to enroll your child in another program, your registration fee will be refunded. * Early Childhood programs can not be discounted for multiple children in family.

FEES AND REQUIREMENTS FOR FOUR YEAR OLD PROGRAMS - St. Peter Lutheran Early Childhood

FOUR YEAR OLD PROGRAMS - FEES

PROGRAM 1 5 Full days from 7:45am-2:15pm

Tuition for families holding membership at St. Peter Lutheran Church is:

Per Child - \$3,760 per year with payments of \$376 beginning August 1, 2012 and the last payment made on May 1, 2013.

Tuition for families not holding membership at St. Peter Lutheran Church is:

Per Child - \$4,950 per year with payments of \$495 beginning August 1, 2012 and the last payment made on May 1, 2013.

REGISTRATION - Per Child - \$200

PROGRAM 2 Monday, Wednesday & Friday Mornings from 7:45-11:00am

Tuition for ALL families is made on a 10 month basis from August through May:

Per Child - \$1,750 per year with payments of \$175 beginning August 1, 2012 and the last payment made on May 1, 2013.

REGISTRATION - Per Child - \$150

PROGRAM 3 - 5 Mornings from 7:45-11:00am (5 Afternoons may be available)

Tuition for families holding membership at St. Peter Lutheran Church is:

Per Child - \$1,950 per year with payments of \$195 beginning August 1, 2012 and the last payment made on May 1, 2013.

Tuition for families not holding membership at St. Peter Lutheran Church is:

Per Child - \$2500 per year with payments of \$250 beginning August 1, 2012 and the last payment made on May 1, 2013.

REGISTRATION - Per Child - \$200

PROGRAM 4 Monday, Wednesday & Friday Afternoons from 11:00am-2:30pm (Wednesday-1:45pm)

Tuition for ALL families is made on a 10 month basis from August through May:

Per Child - \$1,750 per year with payments of \$175 beginning August 1, 2012 and the last payment made on May 1, 2013.

REGISTRATION - Per Child - \$150

MISCELLANEOUS FEES FOR ALL 3 YEAR OLD PROGRAMS

Computer/Technology Fee - \$20.00

Class Party - \$10.00

Student Accident Insurance (Optional) - Various rates - Brochures available in August.

Milk (Optional) may be purchased for full year or half year. Prices will be available in August for students enrolled in the Full Day programs.

Early Childhood programs cannot be discounted for multiple children in family.

The Before and After Care option is billed under the Extended Childcare Program. Please refer to the contract for more information and fees.

CONDITIONS OF ENROLLMENT - St. Peter Lutheran Early Childhood Programs

REQUIREMENTS TO ENTER THE FOUR YEAR OLD PROGRAMS

The following are the conditions for enrollment and are required before a letter of acceptance will be sent verifying your child/ren is enrolled: (proof of appointments will be accepted)

- ◇ Birth verification (birth certificate, not hospital memento) for all students verifying they will be 4 years old by September 1, 2012. Bring an original only (do not bring in a copy) for the office to verify and copy. This is a requirement of the State of Illinois and must be on file in your child's school records.
- ◇ Physical and Dental examination forms, (school will provide) signed by a physician/dentist and parent with general health and completed immunizations on file in the office. Immunization records are a requirement to enter school for the first time. Dental exams are strongly suggested.
- ◇ Student must be able to use the bathroom independently.
- ◇ All required fees must be paid and all forms filled out completely including signatures and/or initialed where necessary.

Tuition statements for all programs will be sent out through email monthly. Payments are spread out evenly over 10 months with the first month's minimum payment due August 1, 2012 and the last payment due no later than May 1, 2013. *If you would like information regarding a 12 month payment plan, contact the Church Financial office.*

Full Tuition paid by Tuesday, July 31, 2012 will receive a 3% discount. This discount cannot be taken for registration or miscellaneous fees.

One Half of Tuition paid by August 1st will receive a 1% discount and One Half of Tuition paid by January 1st will receive a 1% discount. This discount cannot be taken for registration or miscellaneous fees.

Method of Payment:

- ***Vanco Services Auto Debit*** - There is no cost to you for using this service. Tuition fees may be taken from a checking or savings account. Please ask for a form to fill out and return with a voided check.
- ***Cash*** - Not recommended. You will be provided a receipt upon request only.
- ***Check*** - Make check out to ST. PETER LUTHERAN SCHOOL
- ***Credit or Debit Card*** - This form of payment will incur a 3% charge for each use.
- ***On line Payment*** - Set up by you through your bank.
- ***Full Year Payment*** - 3% discount may be taken if paid by Friday, July 31, 2012.
- ***Half & Half Payment*** - 1% discount if half of tuition is paid by August 1, 2012 and 1% discount if last half of tuition is paid by January 1, 2013

Please Note: Tuition payments are due the first day of each month. A \$25 fee will be assessed after the 5th day of the month. A \$30 fee will be assessed to all returned checks. One half of the registration fee is due at the time of registration. The first half of registration is non-refundable. The second half of registration and miscellaneous fees are due **May 4, 2012**. If you are a late registration (after August 1st), all fees are due at time of registration. After the 5th day of school, ALL registration & miscellaneous fees are non-refundable.

New families enrolling after the 2010-11 School Year are required to give their credit/debit card information to be held on file in the Church Finance office. If tuition becomes delinquent two (2) months any time during the school year, you will be notified by the 10th day of the second month of delinquency that payment will be taken through the credit card on file on the 15th of that month.
