### FOUR YEAR OLD Preschool Program for students age 4 by September 1, 2009

**PROGRAM 1** 5 Full days per week from 7:45am-2:15pm - Wednesdays at 1:45 p.m.

**Option:** Before and/or Aftercare may be added to this program in one hour increments from 7:00-7:30am and from 2:15-6:00pm at a rate of \$2.05 for Before care and \$4.10 per hour needed for Aftercare. There are no minimum days required per week. Students must be registered in advance to use this program.

**PROGRAM 2** Monday, Wednesday & Friday from 7:45-11:00am

**Option:** Before care may be added to this program from 7:00-7:30am at a rate of \$2.05 per morning. There are no minimum days required per week. Students must be registered in advance to use this program.

**PROGRAM 3** 5 Mornings per week from 7:45-11:00am

**Option:** Before care may be added to this program from 7:00-7:30am at a rate of \$2.05 per morning. There are no minimum days required per week. Students must be registered in advance to use this program.

**PROGRAM 4** Monday, Wednesday & Friday Afternoons from 11:30am-2:30pm (Wednesday-1:45pm)

**Option:** Aftercare may be added to this program in one hour increments from 2:30-6:00pm, at a rate of \$4.05 per hour needed. There are no minimum days required per week. Students must be registered in advance to use this program.

**Non School Day Option:** When school is not in session, care for St. Peter students is available (except for holidays stated on contract) from 7:00 am-6:00pm. Students must be registered in advance to use this program.

All programs are subject to change and may not be available due to insufficient enrollment. You will be notified and given the opportunity to change to another program. If you do not wish to enroll your child in another program, your registration fee will be refunded. \* Early Childhood programs can not be discounted for multiple children in family.

**FEES AND REQUIREMENTS FOR FOUR YEAR OLD PROGRAMS**

**FOUR YEAR OLD PROGRAMS - FEES**

**PROGRAM 1** 5 days per week from 7:45am-2:15pm - - Wednesdays at 1:45 p.m.

Tuition for families holding membership at St. Peter Lutheran Church is:

Per Child - \$3,400 per year with payments of \$340 beginning August 1, 2009 and the last payment made on May 1, 2010.

Tuition for families not holding membership at St. Peter Lutheran Church is:

Per Child - \$4,480 per year with payments of \$448 beginning August 1, 2009 and the last payment made on May 1, 2010.

**REGISTRATION**

Per Child - \$160

**PROGRAM 2** Monday, Wednesday & Friday Mornings from 7:45-11:00am

Tuition for ALL families is made on a 10 month basis from August through May:

Per Child - \$1,500 per year with payments of \$150.00 beginning August 1, 2009 and the last payment made on May 1, 2010.

**REGISTRATION**

Per Child - \$110

**PROGRAM 3** 5 Mornings per week from 7:45-11:00am

Tuition for ALL families is made on a 10 month basis from August through May:

Per Child - \$2,070 per year with payments of \$207 beginning August 1, 2009 and the last payment made on May 1, 2010.

**REGISTRATION**

Per Child - \$160

**PROGRAM 4** Monday, Wednesday & Friday Afternoons from 11:30am-2:30pm (Wednesday-1:45pm)

Tuition for ALL families is made on a 10 month basis from August through May:

Per Child - \$1,500 per year with payments of \$150.00 beginning August 1, 2009 and the last payment made on May 1, 2010.

## REQUIREMENTS and FEES - continued

### REQUIREMENTS TO ENTER THE FOUR YEAR OLD PROGRAMS

The following is required before the first day of school in the fall:

- ◇ Birth verification (birth certificate, not hospital memento) for all students verifying they will be 4 years old before September 1, 2009. Bring in a copy for your child's records or an original for the office to verify and return.
- ◇ Physical and Dental examination forms, (school will provide) signed by a physician/dentist and parent with general health and completed immunizations on file in the office.
- ◇ Student must be able to use the bathroom independently.
- ◇ All required fees must be paid, all forms filled out completely and signed and/or initialed where necessary.

Tuition for all programs will be billed and sent out monthly. The first payment will be due August 1, 2009 with your minimum payment amount due. All tuition is based on 10 months. Payments are spread out evenly with the last payment due no later than May 1, 2010. Payments are calculated based on the balance of the tuition due divided by the remaining months. Payments of more than the minimum are accepted and will reduce future monthly payments. Full tuition can be paid up before the last payment date, however only the Full Tuition Payment paid by July 31, 2009 will result in the 3% discount.

**Method of Payment:** Simply Giving/Auto Debit      Cash or Check      Full Year Payment  
(3% discount paid by July 31, 2009)

**Please Note:** Tuition payments are due the first day of each month. A \$25 handling fee will be assessed after the 5<sup>th</sup> of the month. A \$25 fee will be assessed to all returned checks. One half of the registration fee is due at the time of registration. The first half of registration is non-refundable. The second half of registration and miscellaneous fees are due **May 1, 2009**. After the 15<sup>th</sup> day of school, ALL registration & miscellaneous fees are non-refundable.

\* Early Childhood programs can not be discounted for multiple children in family.
